

# **CAUTION NOTICE**

The public is also hereby cautioned that the entity **'Manipal Academy of Health & Education (MAHE)'**, which appears to run the aforesaid **'Manipal International School'**, has no concern/nexus/association with **'Manipal Academy of Higher Education Deemed University'** or **'Manipal Academy of Higher Education (MAHE)'**. **'Manipal International School'**, which is without authorization from us, is using marks/name **'Manipal Academy of Health & Education'** and **'MAHE'**, seeking to ride upon the immense reputation and goodwill of **'Manipal Academy of Higher Education (MAHE)'**, which is a household name in the field of education in India and overseas.

In order to protect its immense reputation and goodwill, **'Manipal Academy of Higher Education (MAHE)'**, has already approached the Learned City Civil and Sessions Judge (Commercial Court), at Bengaluru, by way of a Commercial Suit.

The Hon'ble Court has, by its order dated 21.02.2019, restrained, the aforesaid **'Manipal International School'** and **'T. Sudhakar Pai'** from "infringing the plaintiffs registered trademark by using identical trademark like "MAHE" or "MANIPAL GROUPS" in conjunction with any other words or monogram or logo as their trademark, service mark and advertisement for their services or business papers". By order dated 23.04.2019, the Hon'ble Court has extended the said order of restraint till 07.06.2019.

The general public, in particular, parents, students and teachers are advised to be cautious/discerning and not mistakenly confuse the aforesaid **'Manipal Academy of Higher Education Deemed University'** or **'Manipal Academy of Higher Education (MAHE)'** with **'Manipal International School'** or **'Manipal Academy of Health & Education (MAHE)'**.

Any person/ entity dealing with **'Manipal International School'** or **'Manipal Academy of Health & Education (MAHE)'** will do so at its own risk and **'Manipal Academy of Higher Education Deemed University'** or **'Manipal Academy of Higher Education (MAHE)'** will not be liable for any acts of **'Manipal International School'** or **'Manipal Academy of Health & Education (MAHE)'**.
